

ORDER

Govt. College of Education, 20-D, Chandigarh - 160020 submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for an additional intake of 100 (One Hundred) in B.Ed. course of one year duration in terms of Section 15(1) of the NCTE Act, 1993 .

2. The appellate authority of NCTE passed an order dated July 16, 2003, the operative para of the order, is as under :-

"AND WHEREAS the Council noted that the institution is an old and established one, has already made recruitment of teachers through UPSC and has adequate infrastructural facilities.

AND WHEREAS the Council after careful consideration of all aspects of the matter has come to the conclusion that the appeal deserved to be accepted by allowing increased in intake from 200-300 seats in B.Ed. Course to Government College of Education, Chandigarh."

3. The relevant file alongwith all the documents were placed before the 70th meeting of NRC whereby the committee directed that the order for grant of recognition of an additional seats from 200 to 300 be issued.

4. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Govt. College of Education, 20-D, Chandigarh - 160020 for an increase in intake of 100 (One Hundred) seats from existing 200 to 300 (Total 300) seats in B.Ed. course of one year duration from the academic session 2003-2004 Subject to fulfillment of the following before the commencement of the session :-

- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / SCERT is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Director of the concerned SCERT should be submitted before the commencement of the academic session 2003-2004.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

5 Recognition is subject to the condition as per 3 (a) above and that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/State Govt./SCERT.

6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND, WHEREAS**, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned against their name.

3. **AND, WHEREAS**, the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./M.Ed. as mentioned in para 5 below against their name, which may require additional facilities.

4. **AND, WHEREAS**, it has been decided to permit the institution to have the desired number of units subject to fulfilling the following conditions:-

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- The applicant Institution for additional unit will be required to submit the required documents, such as, land documents, Non Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided the additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting Team at the time of inspection.
- The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Section 17/complaint cases etc. as decided by the Northern Regional Committee.

5. **Now, therefore**, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to the following institutions for conducting the under-mentioned programme/intake of two years duration from the academic session 2015-2016 subject to fulfillment of the conditions before 31.10.2015 mentioned in para 4 above:-


