Following Agendas were discussed in the meeting:

- Dr. A.K.Srivastava, Chairperson initiated the meeting of Grievance Redressal Cell and briefed about the importance and working of the Grievance Redressal Cell of the college. Procedure of the submission of grievance to be submitted was explained to the students.
- **General Discussion**-The students (Class representatives) were informed that the college is committed to dissolve the social discrimination, resolve the problems of the students related to college and with the purpose any related issue faced by students can be submitted by students through online/ off-line mode of complaint to the Grievance Redressal Cell. The committee was also informed that details of the grievance redressal committee members had been sent to UGC and Panjab University, Chandigarh for reference with reference to D.O. No. F. 1-133/2022 (CPP-II).
- **SC/ST/OBC related complaints**- Under agenda related to SC/ST/OBC/any other issues/ complaints- as there were no issues submitted by the students, so the students were suggested to ensure that no student faces any kind of discrimination, if so the issue can be brought up to the committee for the solution through proper channel.
- **Any Other-**
 - (1) Students requested that the **age limit of youth fest participation** should be increased to 25 plus years. The committee informed the students that it is a policy matter as per Panjab University, Chandigarh and it is beyond the power of

grievance redressal cell. It was suggested that the student can email or approach youth welfare department of Panjab University for any changes required.

- (2) Students also put forward the problem of **sanitary pad vending machines** to be installed in college washrooms. The committee informed that it has been installed in girls hostel but need to be refilled on regular basis and funds will be identified to buy and install sanitary pad vending machines in girls common room and washrooms. The committee also decided that the problem needs to be presented before the principal of the college for immediate action to be taken in this respect on priority basis.
- (3) As some students were facing problem regarding **hostel accommodation** so the committee suggested the College administration and Hostel committee to look after it.

- The committee presented the problem before the principal of the college and requested for immediate action to be taken in this respect on priority basis.


3) Hostel Accommodation
